Course Delivery: This course includes an intensive 4-day field trip to Lethbridge, Alberta followed by the 2-day FWNET student workshop where the final project will be presented.

Prerequisites:

- Restricted to MSc and PhD students formally enrolled in the FWNET CREATE program. This is a mandatory training component which must be completed in the 1st or 2nd year of training.

Course Description:

This field course exposes students to issues, challenges, and opportunities which occur at the interface between water management and food production. These issues will be explored through a 4-day field trip to southern Alberta, where food and water sustainability issues are prevalent and

can be easily demonstrated. Students will visit and engage with a range of organizations involved in food production and water management. At the end of the field trip, students will document and reflect on their experience by creating a video which demonstrates their understanding of food-water nexus issues.

Learning Outcomes:

At the end of this course, students will be able to:

1. Demonstrate a strong conceptual understanding of how water is managed to support food-production in the study region (southern Alberta).
2. Identify challenges and opportunities which exist at the intersection of water management and food production.
3. Identify and appreciate different perspectives on food-water nexus issues.

Assessment

Students must receive a grade of 60% (master's students) or 70% (PhD students) to achieve a passing grade in this course. Participating in all of the field trip stops (unless excused by the instructor) and completing the reflection assignment is mandatory for passing this course.

Participation: (30%)

Students are expected to fully engage in the tour stops. Dialogue with the hosts at each stop, other students, and course instructors is expected.

Video Reflection Assignment (70%):

The main deliverable of this course will be a single video reflection assessment that will be completed in a group of 2 students. The video will provide an overview of the student experience on the trip and a synthesis of the food-water nexus issues that were discovered along the journey.

60-69 Poor

A generally weak performance, but with some evidence of

- a basic grasp of the subject matter;
- some understanding of the basic issues;
- some familiarity with the relevant literature and techniques;
- some ability to develop solutions to moderately difficult problems related to the subject matter;
- some ability to examine the material in a critical and analytical manner.

<60 Failure

An unacceptable performance.
